Special Dates of Significance in The Growth of "The Pond"

- 1933 -- The site selection for the Oakfield Recreation Club.
- 1933 -- The land is leased from the Greene family for 100 years.
- 1934 -- The first Dam is built of dirt for us by a man from U.S. Gypsum.
- 1935 -- Incorporation is completed (under Fellowship Corp. Law).
- 1937--Outside bathroom is built.
- 1938 -- Shufflebourd Court is built
- 1962 -- Pond dredged for \$1000,00.
- 1964 -- Pavilion Built
- 1971 -- The land is officially deeded to the club by Mr. & Mrs. Greene.
- 1974 -- A small land dispute is settled (ORC buys Abdella property).
- 1975 -- A road is built on West side of Pond.
- 1978 -- Concrete Dam is constructed by hand.
- 1982 -- Removal of Cottage # 21.
- 1983 -- Construction of Barn begins, using wood from Cottage #21.
- 1989 -- Pond dredged again, for \$20,000.00
- 2006--Laundry Room & equiptment project completed.
